The board is easy-to-cut, very versatile, but strong for use in interior applications.

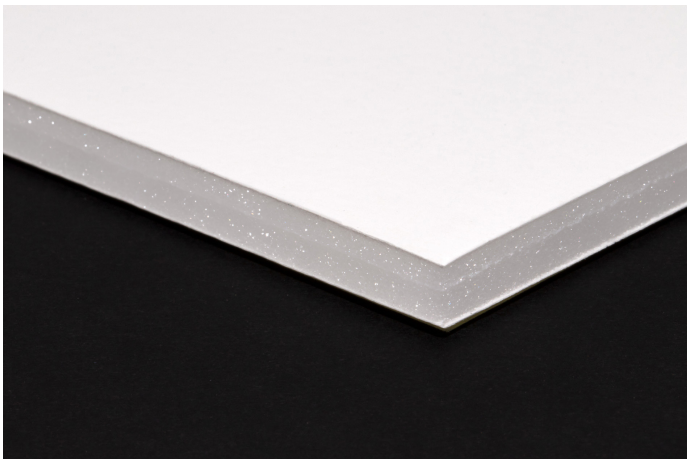
